Regarding France no information on a new member for participating CFPA SC had been received.

4 Members' reports

The participating members are asked to report on how their company manages the current challenges due to the Corona disease.

Belgium: New rules apply as of today. So the "real" situation is difficult to describe. However, ANPI has never closed down. The laboratories were always active and certifications were and are issued. ANPI focuses on "PR-work" to show that the company is still active.

Inspections on site are carried out, if this is ok for the customer. Nevertheless, there are many restrictions.

Sweden: Up to now no second wave has occurred. There were no hard restrictions (no lockdown). However, people do both "normal" office and home office.

The main problems are faced by elderly people suffering from infections.

Some face-to-face meetings were realised. Training is more challenging. Here the current digital transformation is helping to cope with the restrictions.

Denmark: Home office is used quite often and until today.

Training is heavily restricted as no physical training in groups is possible. These days, theory is trained online and the physical part is done only with a very small number of students. Difficult for some students are their individual national rules as it may be difficult for them to get home again after participating in a course in Denmark.

Swiss: A lockdown was faced in March. But mostly full time work was possible.

The summer was easier to manage than today because the country is facing a second wave. Rules change a lot and differ from canton to canton.

Training is quite complicated. At first, the strategy of online training was followed. Today live training is carried out again. But not only the students but also the teachers have to wear a mask. The daily paperwork is done more or less from home office.

England: Firstly the British strategy was the same as in Sweden. But in March a lockdown became necessary. Since September, schools are running normal again.

England has implemented a 3-level system. Level three is similar to a lockdown with many restrictions (it currently applies in the north of England). The less strict level 2 (which Tommy is facing in his home area) demands that not more than 6 people meet outside, wearing masks. Gatherings at home (except with family members) are to be avoided. Even the south is facing growing numbers these days.

Finland: Most facts have already been mentioned before.

The summer was quite ok. Now, the numbers are rising. All SPEK-colleagues are asked to avoid public transport. Online work is going quite well due to the fact that these techniques are well developed in Finland.

Turkey: The infection rate in March was acceptable. Then the younger (under 20 years) and the elder (over 65 years) had to face a lockdown. After a bad development of the figures, restrictions were increased. These days, wearing a mask and keeping distance to foreign persons is mandatory and an infringement is punishable by law. Working from home office is standard since March.

Germany: Laboratory work is carried out nearly as normal, of course with safety measures. Masks must be worn on the whole campus. Where possible, home office work is done. Business trips abroad are heavily restricted. Within Germany, business trips are done as far as the costumer agrees on the visit which he very often does.

Work meetings are held online in most cases.

For two months in spring, no face to face training was possible. However, costumers are asking for live training so VdS tries to restart the live trainings.

One major problem, as already mentioned above, are the often changing rules (Germany/NRW, the country where VdS is located, have had four significant changes in one single week). The rules not always seem clear or logical. Conferences are planned to be held both live and via livestream on the Internet.

The situation is more or less similar in all CFPA member countries. Rules are changing depending on the current situation.

Everybody is facing the challenge to offer trainings without having the possibility to teach face to face, as before, and in larger groups.

5 Security Guidelines for Businesses

Per had revised the guidelines. Taking these latest changes into account SC had been asked to check and finalise the work on the Security Guidelines for Businesses.

The topic has been discussed. As no further comments are given, the discussion ends with the decision that the developing work on the guideline is done.

Paulus will work out the layout and possibly do a linguistic revision, as necessary. The final document will be handed to CFPA-SC for confirmation (or last comments). Then the document can be published.

6 Arson Document

SC had been asked to discuss the document and, if possible, to finalise the work on the Arson Document.

1st day: SPEK had created a new document based on the work SC had done in Italy. This new document had not been circulated beforehand. Lauri provides the document and it is given to all SC-members. The decision is that everybody reads the document so a discussion of the contents is possible on meeting day two.

2nd day: Everybody has read the document. Paulus had included headlines in matching positions. So the structure of the document can be rated. The structure is confirmed by SC.

The whole document has been discussed on day two. Some specific figures (as the percentage of arson related loss in the insurance industry) was formulated in more general terms as the information would be quite hard to proof. Several statements have been rephrased so the meaning of the contents is easier to understand.

Paulus will create a final version of the document.

The final document will be circulated around SC for taking note of it and at the same time the Arson Document will be handed to Hardy Rusch. Hardy will be requested to add comments from the GC. The GC meeting will be held at the end of November.
