Minutes of meeting CFPA-E Training Commission

Minutes by Howard Passey **Location** Lisbon **Date** 6-7 March 2014 Point **Notes** Who Deadline 1: Welcome & opening of the meeting Passey opens the meeting and welcomes all to Lisbon (Portugal). Thanks passed to Maria João Conde, Ana Ferreira and APSEI for hosting the meeting and making excellent arrangements. 1a: New participants and apologies for absence Passey welcomes two new participants, Pia Mark from DBI, replacing Heidi Juel Johansson and Hans-Heinrich Wolfensberger (Harry) from SWISSI who is attending his first TC meeting. Passey also welcomes his colleague from FPA, Sue Tyley, who is already known to some members having attended other CFPA-E TC & Hot Work meetings in the past. Tyley has been undertaking some work on qualifications frameworks to be discussed later in the meeting. See also item 1b. Passey notes that pleasingly all participants are in attendance and there are no apologies for absence. 1b: **Retiring participants** Passey confirms, following discussion with the MC and some members of TC that he will be stepping down from the TC and as its Chairman as of the forthcoming General Assembly in May 2014; hence, this will be his last TC meeting. Tyley will be representing the FPA UK in future. Following recent difficulties in finding a Deputy Chairman for the TC the MC were concerned to ensure that there was a suitable candidate to take on the Chairmanship so that a smooth handover of responsibility would be possible. Following much discussion Tyley agreed that she would be prepared to be Chairman. This proposal was supported unanimously by the TC and will be recommended to MC and GA GA in the GA in May for ratification. May 14 2: Approval of the agenda Agenda receives unanimous approval. •	The concerns expressed by the TC relating to the use of the phrase 'certification' were discussed with the MC at their last meeting. Jesper Ditlev had suggested discussing with Johansson who has experience of the approach taken in Denmark, however, she is no longer with DBI and Mark has only just taken on this role and as yet unaware.		
•	A number of examples of approaches taken in other member countries were highlighted with the following themes: -		
	 For certification of persons the certification needs to be entirely independent of any training 		
	 You do not need to do training to undertake examinations / become certified 		
	 An independent certification body would be required. Other aspects discussed included: - 		
	 AIAS has a certification body linked to national accreditation body and certifies individuals for 'fire safety at work'. 		
	APSEI certifies for extinguisher maintenance and fluorinated gases. NERA CERS is perceived in Spain.		
	 NFPA CFPS is popular in Spain Hot works in Scandinavian countries – training and certification are kept remote from each other. 		
	 For thermography (mainly one–man operations) the phrase 'qualification' is used. 		
	 It was proposed that CFPA-E develop different CFPA-E professional profiles for qualifications at EQF levels across Europe. Once on the EQF all providers can pick-up and use.

•	The need to formally develop and approve a business case for all new courses was requested by the MC with links to a related Guideline wherever appropriate. In addition to existing protocols for support of new courses this approach will strengthen and improve decision making processes.		
1	Development of Training Packages		
-	Another issue for development from the MC was discussed. In recognising that blended learning approaches were being requested by many customers in many countries it was agreed that this would be a good idea. A number of potential issues would need to be resolved – in particular that of language, cost and the speed of technological change. Hebbelynck explained that in France there is growing interest / requests for 'serious games' to support learning and asked if it would be possible for CFAP-E members to work

The SFPE would like, once agreed, to develop suitable courses for engineers across Europe. Tyley went on to explain that Sector Skills organisations and F&RS in the UK were also interested in developing National Occupational Standards and/or training in this area. Rodriguez Garcia confirmed that in Spain some courses were offered but based on national regulations. Zucarro explained that there were two approaches to design either prescriptive or performance based. It was agreed that it is difficult to develop courses that covered prescriptive approaches as they differ in each country. There are 50 slides and the cost is 350 Euro. The course uses flash animation includes a questionnaire but no certificates.
