# **Part I: Common general items**

## 1. Welcome

Mingyi opens the meeting and welcomes all participants.

- b) Introduction of members: All participants introduce themselves, as Miguel attends first time the common meeting of both groups started at the meeting in October 2018 in Zürich.

# 2. Minutes about the last meeting on 21<sup>th</sup> March 2019 in London

a) Approval of the minutes: The present draft minutes are approved without any changes.

## 3. General coordination of NHG and GEI-6

The participants exchange briefly the current natural hazard events in member countries, amongst others floods caused by heavy rain and hail. # Part II: CFPA-E NH Group items

## 4. Revising discussion:

- a) Guidelines that are more than three years old
  - Guideline No. 2: 2013 N "Business Resilience": Amar introduces his updating draft. Due to the discussion afterward the following items should be considered in the continuing development:
    - Interaction between risk management and BCM
    - Glossary for used terms, e.g. likelihood
    - Historical experiences, especially on human factor and safety
    - A updated picture on BCM with English lettering (Action Hans)
    - Reference to ISO Guideline (Action Taina)
  - Guideline No. 5: 2014 N "Snow Loads": Mingyi introduces due to discussions at the meeting in London the updating draft for the final approval. In this connection, some detail additions have been completed, e.g. including typical specific weights of snow and an exemplary consequence of careless snow removal. With a deadline for last comments of 4 weeks after the meeting, the updating draft for publication is approved.

Note for the drafting of the minutes: So far, no comments have been received

## b) Others

- Guideline No. 6:2016 N "Forest Fires": According to experiences on forest and landscape fire in last two years in member countries and application of new technology, e.g. drone and satellite, all participants see the updating need. All members are requested to provide appropriate inputs. Mingyi will send the first updating proposal from Germany to Miguel.

## 5. Proposals for discussion

a) "Heavy rain": In general, the present draft from Mingyi and Hans is considered good and useful. Therefore, this draft guideline will continue developed and especially completed with pictures on flooding situation and losses in member countries. This is requested from Mingyi also at the common meeting of all CFPA-E commissions. In parallel, it should be clarified with MC whether a guideline could be developed by less than 5 member countries.

Note for the drafting of the minutes

- Due to the limited participation of member countries in NHG and according to the decision of MC, guidelines on natural hazards can be developed by less than 5 member countries
- First pictures on floods caused by heavy rain are provided by Guido (Italy) that will be selected by NHG at the next meeting in Linz
- b) "Ensuring supplies of firefighting water in extreme weather conditions": Hans presents his summary based on his research and discussion with fire fighters in Austria and asked for further inputs from other member countries. Miguel refers to the last draft that will be sent to Hans for continue development.

*Note for the drafting of the minutes* 

- The last draft produced by Adair (UK) is sent by Miguel on 17<sup>th</sup> October 2019.

## 6. Ideas for new proposals (Waiting list) - all

The waiting list is jointly screened and updated with a new work item on adaptation to climate change related to natural hazards and extreme weather events. According to the present uncertainties of climate projections on the one hand and the high losses caused by extreme weather events on the other hand, a statement for the CFPA-E-webpage with consideration of views of risk management will be proposed by Mingyi and discussed at the next meeting in Linz.

Note for the drafting of the minutes: MC that meets in parallel to the meeting of NHG is informed about the ongoing discussion and agrees in general the advance of NHG

## 7. Time limits until next meeting – Mingyi

The last comments for final approval of the updating draft on snow (Guideline No. 5: 2014 N) should be sent to Mingy at least 4 weeks after the meeting

All results of agreed works should be sent to Mingyi 6 weeks before the next meeting in Linz for the timely distribution in both groups.

## 8. Any other business – all

Mingyi inform the participants about the thematic discussion at the common meeting of all commissions on linguistic check for all draft. Miguel points out that some budget of GC can be used for the financing of the necessary check.

  - In this connection, Mingyi announces the planned internet landing page of Austria, Germany and Switzerland (D-A-CH) that should guide interesting user to the national webpage with information on
  - loss experiences
  - protection concepts and
  - hail resistant building material and construction approved with standard testing procedure and available at the market of the three countries.

Note: From the view of both groups, the information about the launch of the landing page of D-A-CH should be also published at the CFPA-E-Webpage
